# **Electric Rates Change**

Energy Saver/Conservation Rate 6 is designed to reward residential customers who build or upgrade their homes to high efficiency standards, as prescribed by the International Energy Conservation Code. These standards are subject to change and affect ceilings, lighting, walls, floors, windows, doors, ducts, attic vents, water heaters, air conditioning, chimneys, and fireplaces.

Air conditioning systems must have a SEER rating of 1.0 SEER higher than the current ENERGY STAR requirements (minimum of SEER 16) to qualify for service under Rate 6. This rating is subject to change as energy codes are updated or revised.

## **Electric Rates Change**

The Public Service Commission of South Carolina ("PSC") approved changes to Dominion Energy South Carolina ("DESC") retail electric rates. The effect of these adjustments is that there will be an increase to retail electric rates. Bill impacts will vary depending upon each customer's class of service and usage characteristics. The changes are pursuant to: 1) an increase in the Company's retail electric fuel factors driven by an increase in projected fuel costs; 2) an increase to the Company's Demand Side Management Component for residential and small general service customers (with no change for medium general service customers, and a slight decrease for large general service customers); and 3) a decrease to the Company's Pension Costs Component. These changes will become effective for bills rendered on and after the first billing cycle of May 2025.

The Renewable Energy Resources charges, implemented in 2016 to recover costs and incentives associated with the implementation of Renewable Energy Resources in South Carolina, cannot exceed \$1 per month for residential customers, \$10 per month for commercial customers, and \$100 per month for industrial customers, in compliance with the Distributed Energy Resources Program Act of 2014.
